## Authors

**Alyse Bertenthal** is Assistant Professor of Law at Wake Forest University School of Law. Prior to that, she was a Postdoctoral Scholar and Mysun Foundation Fellow in UC Irvine's Environmental Law Clinic, where she focused on environmental justice advocacy and policy reform. Her research interests include how cultural, legal, and scientific practices affect the construction and implementation of environmental law and justice; the intersection of law and language; and how legal expertise is generated and performed. She received a BA in Literature from Yale University, a JD from the University of Chicago, and a PhD in the interdisciplinary field of Criminology, Law and Society from University of California, Irvine, where her work was supported by awards from the John Randolph Haynes and Dora Haynes Foundation, Mellon/American Council of Learned Societies, the National Science Foundation, and a Microsemi/Peterson Fellowship. She has published articles on a variety of topics related to environmental law and environmental justice in peer-reviewed journals and law reviews including *Environmental Justice*, *Law & Literature*, *Law & Policy*, and the *Wisconsin Law Review*.

**Amanda Frost** is the Ann Loeb Bronfman Distinguished Professor of Law and Government. Professor Frost writes and teaches in the fields of constitutional law, immigration and citizenship law, and judicial ethics. Her scholarship has been cited by over a dozen federal and state courts, and she has been invited to testify on the topics of her articles before both the House and Senate Judiciary Committees. Her non-academic writing has been published in *The Atlantic*, *The New Republic*, *Washington Post*, *New York Times*, *Slate*, *USA Today*, and *The American Prospect*, and she authors the "Academic round-up" column for SCOTUSblog. In 2019 she was awarded a fellowship from the American Council of Learned Societies to complete her book, *You Are Not American: Citizenship Stripping from Dred Scott to the Dreamers* (2021), which was named as a "New & Noteworthy" Book by the *New York Times Book Review*.

**Lynn Kaye** is Associate Professor of Rabbinic Literature and Thought in the Department of Near Eastern and Judaic Studies at Brandeis University. Her research interests include Jewish law and narrative, philosophies of time, legal theory, and critical and literary theory. She earned a Master's degree from the University of Cambridge and a PhD from New York University, during which time she held fellowships at Benjamin Cardozo School of Law and NYU Law School. Professor Kaye authored *Time the Babylonian Talmud: Natural and Imagined Times in Jewish Law and Narrative* (Cambridge University Press, 2018), winner of the Association for Jewish Studies' Jordan Schnitzer Book Award, and a finalist for the National Jewish Book Award for Scholarship. She has published articles in the *AJS Review*, the *Journal of the American Academy of Religion*, *The Journal of Jewish Thought and Philosophy*, *Nashim: A Journal of Jewish Women's Studies and Gender Issues*, and *Currents of Biblical Research*.

**John A. Peterson III** graduated from Harvard Law School in 2016 and is currently in private law practice. He clerked for the honorable Justice Constandinos Himonas of the Utah State Supreme Court and for the honorable Judge Ralph K. Winter Jr. of the Second Circuit Court of Appeals.

**Adi Yucht** is a Lecturer (Assistant Professor) in the Haim Striks Faculty of Law at the College of Management Academic Studies. Before that, she served as a Postdoctoral Fellow at Sciences Po Law School from 2016 to 2019, a Visiting Doctoral Fellow at Berkeley Law School in 2015, a Research Fellow at the Edmond J. Safra Center for Ethics at the Tel Aviv University Faculty of Law in 2013-

2014, and a Visiting Doctoral Fellow at Columbia Law School in 2012-2013. She earned her PhD from the Tel Aviv University Faculty of Law. Professor Youcht's research interests are in the sociology and philosophy of law and bioethics, the body and the law, disability studies, science and technology studies, critical military studies, and law and political thought.
